## RIVER MURRAY BILL

There is a definite ecologically sustainable thrust to the legislation, amending many existing Acts to give the Government more powers in relation to irrigation practices, planning, pollution, and other matters. Submissions will be called for from the Community in relation to this Bill.

# S.A. SALINITY STRATEGY

Even through there has been a 30% increase in irrigated area in S.A., this has been achieved with a 10% increase in water use.
